SWIM - 5/6 yr olds will swim width of pool, 7/8 will swim two widths, all other age groups will swim length of pool (50 meters). Life vests are allowed. Racers must be in designated pool area by 7:50am. Race starts promptly at 8:00am.

BIKE - Route is 1.17 miles. You must wear a fastened helmet and tennis shoes. Training wheels accepted. You must walk your bike in transition areas. One chaperone can help the child find their bike and get their helmets and tennis shoes on. NO CROCKS

RUN - a .65-mile run. A chaperone can run alongside the child who is under 6 years old.
